PLAYER APPLICATION and PARTICIPATION AGREEMENT

Please Read The Following Carefully Before Signing

I, the undersigned hereby acknowledge that engaging in athletic sports- including the tennis programs and activities offered and conducted by Top Seed Tennis Academy, Inc. ("Top Seed")-may result in accidents and/or injuries. But notwithstanding such danger and risks, and as an express condition of being allowed to participate in Top Seed's tennis programs and activities, the undersigned, for himself/herself/as parent or guardian of the above-named player, freely and voluntarily accepts all risks and hazards associated with or incidental to participation in Top Seed's and activities, including use of the facilities where such programs are conducted. The undersigned hereby further expressly waives any claims for injury or damage arising from or relating to the above-named player's participation in Top Seed's programs, whether injury results from negligence or any other cause, and agrees to defend, indemnify and hold harmless Top Seed or North Ranch Country Club and its officers, employees and /or agents, from and against any and all liability, charges and/or expenses which may arise by reason of the above-named player's participation in Top Seed's programs or activities.
